- 9.2. An effort to provide updated rosters to each chair will be made. (Refer to Do Shaver report.) Question on use of cell phones with BOE is pending.
- 9.3. GOP State Headquarters sent Chairman Levy “Important Election Dates and Staff Personnel Phone Extensions.” Email was forwarded to Dick Kuehl. Dick has not forwarded this to Executive Committee but will do so promptly. [\(Update: Forwarded and submitted for posting on website on 12/2/2011\)](#)
- 10.0. Old Business
- 10.1. Fund Raiser – Welcome 2012 Event – Bill Parke presented the actions of this committee. An early January date seems to be impractical. Registered voter concentration over Moore County was an important consideration in locating a place to hold this event. Bill Scott moved the committee be authorized to spend seed money of up to \$3000 to advertise and create this activity. A goal will be to make this a break-even activity. Do Shaver provided a second to the motion which passed unanimously.
- 10.2. Chair, Outreach Committee – Chair Do Shaver gave a preliminary report on new voters registered, Republican, Democrat, Unaffiliated. Plans are being developed to provide information for Precinct Chairs to personally contact these voters. Increased use of mobile phones in lieu of normal wired phones is becoming a problem of contacting new voters.
- 10.3. Finance Committee – There was no report from this committee.
- 10.4. Bob Tweed reported on the progress made to locate a MCRP Headquarters early in 2012. Several ideas were offered to the committee. Registered voter concentration over Moore County was an important consideration in locating the office. Candidate materials will be arriving and the storage and distribution must be planned. Also reviewed having an auxiliary office in NW Moore County
- 10.5. Special Opposition Research Committee: Chair Russell Vansant, gave a brief report on the research. Several reference books and websites were mentioned. These materials are referenced as End Notes.<sup>1</sup>
- 11.0. New Business
- 11.1. Next Meeting was set: – Tuesday, January 24, 2012 – *(Note: County Commissioners meet on the 1st and 3rd Tuesdays. MCRP will normally meet on the 2nd or 4th Tuesday.)*
- 11.2. Dick Kuehl moved: “To go into a Committee of the Whole to consider (GOP Presidential Candidates) and that Chairman Levy retain the gavel to direct the committee. It was seconded by Bob Tweed and passed unanimously.
